

# McLaren Health Plan Primary Care 2017 Pay for Performance Program (P4P)

#### I. Introduction

McLaren Health Plan is committed to providing high quality, cost effective, health care to our members. By establishing a Pay for Performance (P4P), McLaren Health Plan builds a strong partnership with our contracted primary care providers, resulting in improved access to health care services for our members. The P4P provides incentives that optimize quality by recognizing the outstanding efforts of our primary care providers. The ultimate goal of the program is to improve health care outcomes.

### II. General Terms

A primary care provider can receive up to \$2.00 per member per month (pmpm). This is awarded based on Medicaid HMO and Commercial HMO & POS membership as of the end of the calendar year. The actual award is subject to the following conditions for the measurement year:

- A. The primary care provider must be contracted with McLaren Health Plan for all products Commercial, Medicaid, Medicare Advantage, and McLaren Health Advantage for at least 6 months of the measurement year <u>and</u> be contracted at the time of the payment.
- B. The primary care provider must have an annual average of 50 members per month.
- C. The primary care provider must initially contact McLaren Health Plan to enroll in the program, and the contact must be effective before June 30 of the measurement year.
- D. To be eligible, members must be assigned with the primary care provider for 6 months of the year.
- E. 90% of all claims during the measurement year must be submitted electronically.

## III. Measures, Specifications, Performance Goals, and Award

The following table describes the program's measures, specifications, goals and awards. Provider type (Pediatric, Family Practice, Internal Medicine) is defined to allow for a total award of \$2.00 pmpm for all primary care providers. Measures and awards are reviewed periodically, and goals are adjusted annually or sooner if warranted.

HEDIS specifications are utilized to define the codes, eligible population and any exceptions to the measurement.

A *Quick Reference Guide* is available that briefly explains the P4P in an easily presented format. The *Quick Reference Guide* displays the key elements of the program and is separate from this program description.

# IV. Program Payment and Distribution

The program calculation and payments will be made as follows:

- A. Determine the score for each measure based on McLaren Health Plan specifications
- B. Compare against set goal for measurement year
- C. Calculate award pmpm for membership as of December 31 of the measurement year

The payment will be made within 9 months of the end of the next measurement year. Payments will be made to the individual primary care provider, or as the physician group directs.
