Standard 4.1 Prevention Programs

Tobacco/Smoking Cessation Workshops

A certified tobacco-treatment specialist at McLaren Flint offers two smoking cessation workshops each month at the Cancer Institute. In addition, individual counseling sessions and group workplace



presentations are also available at no cost to the Flintarea community. The number of workshops, classes and presentations are dependent on the level of public interest. In 2016, no

workshops were held at the Cancer Institute, 15 individual counseling sessions were conducted, and one tobacco/smoking cessation presentation was given at a local business.

Standard 4.2 Screening Programs

Colorectal Cancer Screening Event

During the month of March, McLaren Flint

conducted a public service campaign to encourage members of the community that fall within the screening guidelines to request a free Fecal Immunohistochemical (FIT) test. Radio and



print messaging ran during the month. Fifty-seven kits were distributed. Twenty-seven of the tests were completed and returned for processing. All individuals with negative results received a letter from a registered nurse. The three individuals whose results were positive were contacted directly by a registered nurse and encouraged to receive follow-up testing and treatment.

Breast Cancer Screening Event

On August 23 and August 30, 2016, McLaren Flint in conjunction with the Food Bank of Eastern



Michigan held a breast cancer screening event at the McLaren Imaging Center.

A total of 22 women received mammograms. Exit interviews were conducted at the

completion of the mammogram and participants were given 12 pounds of food from the Food Bank of Eastern Michigan.

Lung Cancer Screening Services

The Comprehensive Lung Cancer Detection Program through McLaren Flint provides access to advanced diagnostics and care for individuals at an increased risk of lung cancer by a team of medical experts in the management of lung disease and the treatment of cancer. The Comprehensive Lung Screening Program is accredited by the American College of Radiology (ACR) and includes: Initial consultation to determine eligibility for lung screening, a lung scan performed on a 128-slice CT by certified CT technologists, access to physician specialists if the scan identifies lesions, and a multidisciplinary conference to review diagnosis and collectively form a recommended best course of treatment.

From January 1 through October 31, 2016, 485 qualifying individuals received the lung scan. Forty-seven of these patients' scan results revealed lesions and they were referred for further care and the additional services of the Program.


Cancer Program Practice Profile Reports (CP3R)

The Cancer Committee ensures and monitors that patients treated at McLaren Flint receive care according to nationally-accepted measures. The



Commission on Cancer measures compliance with current CoC quality reporting tools - the Cancer Program Practice Profile Reports. Below is a summary CP3R performance grid

that reports 2014 breast cancer cases treated at McLaren Flint. We are proud that our program is exceeding all required performance expectations of the Commission on Cancer.

The ACoS Commission on Cancer has defined four Cancer Program Practice Profile Reports (CP3R) for Breast Cancer

Image or palpation-guided needle biopsy to the primary site is performed to establish diagnosis of breast cancer (nBx)	91.80% (67/73 patients)	80%
