### Supplement A: Flu Vaccine Administration Codes

#### Category 1: Administration with Counseling

- **90460:** Immunization Administration, through 18 years of age, via any route of administration, with counseling by physician or other qualified health professional; **first or only component of the vaccine.**
- **90461:** Immunization Administration, through 18 years of age, via any route of administration, with counseling by physician or other qualified health professional; **each additional vaccine or toxoid component administered**.

#### To report these codes, substantiate three elements:

- 1) **Patient age:** Counseling codes can only be used through 18 years of age. Once patient turns 19, the second category of admin codes must be used (*see Category 2 below*).
- 2) Face-to-face counseling with the patient and/or family: Parents often have questions about vaccines, and the provider may spend significant time on education and counseling. Documentation of the encounter should detail the vaccines given and summarize patient risk factors or concerns, and information shared with the family (possible side effects/benefits of the vaccine). If the provider does not document face-to-face counseling, the second category of admin codes must be used (see Category 2 below).
- The number of vaccine or toxoid components: NOT the number of individual vaccines administered. Report 90460 for the first component administered, and one unit of 90461 for each additional component administered. See the grid below for more information.

<u>\*Note for VFC Sites</u>: If the patient is a VFC patient, users must pick the corresponding Counseling code that has the VFC prefix.

#### Category 2: Administration without Counseling

- **90471:** Immunization Administration (includes percutaneous, intradermal, subcutaneous, or intramuscular injections); 1 vaccine (single or combination vaccine/toxoid).
- **90472:** Immunization Administration (includes percutaneous, intradermal, subcutaneous, or intramuscular injections); each additional vaccine (single or combination vaccine/toxoid).
