Prescription Drug Monitoring Program (PDMP) and Opioid Review Enhancement Overview

Enhancement: Effective 11/8/22, Cerner has contracted a new vendor, Dr. First, who will send a request to the state PMP to obtain and give access to NarxCare reports via the new Opioid Review component in Cerner PowerChart.

The current NarxCare component will be replaced with the Opioid Review component in Cerner PowerChart. This enhanced component will provide more information to providers as described below.

Current functionality does not allow for a date/time stamp of when the Drug Report was reviewed	 There is a checkbox within the component where users can certify that the PDMP information was reviewed. The Mark as Reviewed button will be used to confirm the Provider reviewed the PDMP report in Cerner. This also writes a date/time stamp for reporting purposes. A green checkmark will display to indicate the report has been reviewed, including the name of the provider and date/time reviewed.
• There isn't a way to tell when the report was last reviewed or by whom.	 The name of the Provider who last reviewed the report will display within the component, along with the date/time it was reviewed.

Opioid Review Component Overview

The Opioid Review component is a risk tool that integrates the process of analyzing controlled substance data from the state Prescription Drug Monitoring Programs (PDMPs) website into the provider's workflow. This process makes it easier to gain insights into a patient's-controlled substance use and obtains aggregate information pertaining to:

- Number of Providers
- Number of dispensing pharmacies

- Amount of drug overlap in history
- Current number of active prescriptions
- Amount of drug equivalent units/days' supply

The PDMP Review accumulates 2 years of historical prescription data from providers and participating pharmacies including quantities and active prescriptions and presents interactive, virtual representations of the data, as well as complex risk scores based on that data. Every PDMP report includes type-specific use scores for narcotics, sedatives, and stimulants. Follow the steps below to access this information and view the drug report.

Opioid Review Component

Follow the steps below to complete the Prescription Drug Monitoring Program (PDMP) and Opioid Review within the patient's chart.

2) Locate specific risk factors for prescription opioid management of pain at the top of the Opioid Review component.

- a. More than 3 Opioid Rx in the last 90 days: Displays a Yes if the Patient has had more than 3 opioid prescription orders written in the last 90 days.
- b. **Co-prescribed Opioid and Benzo:** Displays a **Yes** if the Patient may have concomitant use of prescribed opioid and benzodiazepine medications.
 - <u>Note</u>: The information that displays here pertains to prescription orders placed for the patient within Cerner PowerChart.

 - The "Query of PDMP Measure" PI report keys off the checkbox being reviewed and provides insight into physician usage and compliance of PDMP.
- 11) The **PDMP Reviewed** section will now display a green checkmark along with the Provider's name and date/time of review.
