

<<Updates to Preanesthesia Assessment>> <<All Anesthesia Providers>>

On 11/7/22, there will be an update to the Preanesthesia Assessment to make ASA, Mallampati, and Intended Anesthesia Type required. After this date, a Preanesthesia assessment will not be able to be "Signed/Submitted" unless those three fields are addressed.

They can still be "Saved" and subsequently modified without the three required fields, but the record can no longer be "finalized" without them

When a Preanesthesia Record is opened, the anesthesia provider will now see two red asterisks next to "Physical Examination" and "Assessment and Plan" indicating that there is a now a required field in that section



When you click on those sections, you will see the actual required fields highlighted in yellow and preceeded by an red asterisk. Once you address the required element, the yellow highlight goes away. No other change are currently being made to this documentation—just making the regulatory required fields, "required" so the assessment cannot be accidently signed without addressing.
